MEMBERSHIP CAN BE OBTAINED FOR THESE PEOPLE IF THEY ARE OVER 15 YEARS OF AGE.

THERE IS A MEMBERSHIP CALLED ASSOCIATE FOR THOSE WHO ARE SINCERELY INTERESTED IN THE NATIVE PEOPLES AND WHO WISH TO HELP.

to encourage and promote honest social fellowship among the original and non original peoples.



David Nasogaluak - Sachs Harbour Willie McDonald - Fort McPherson C.O.P.E. has been the voice of its members on Banks Island who were threatened by oil exploration which the Federal Government intended to allow without any consultation with the people of Banks Island and without any regard for the damage which might be done to the trapping of the whitefox which has brought in a good independent living for the people of Sachs Harbour.

As a result of many meetings, speaches and threatened court action, the government finally consulted with the people and controls were placed on the activities of the exphoration company.

For over a year the consultation has gone on —— COPE is still not satisfied with what has happened — Every time the the people are talked to, the plans have been made already. This is not consultation — We feel the people of the north in many areas are being played with. The people were given the right to watch the exploration work to make sure all the rules were lived up to by the company. But it is only in very strong areas like Banks Ialand and Coral Harbour in the Eastern Arctic that this is carried out. Also in Old Crow. —If people do not make a strong stand they will receive a lot of nice talk, but it is only cream.

C.O.P.E says that rights do exist and that the government and citizens of the United States have recognized the rights of the original people of Alaska by making payment to them of a billion dollars in settlement of their claims and also a percentage of the oil and minerals.

Oil development only last a very short time. Jobs are important to people and they should take part in these jobs as much as possible. They will not last long. C.O.P.E. always asked = If there is no settlement off or bank set up for the people— What will happen after the jobs with the oil companies are gone.???? That's a big question that few people want to be bothered with — It is hard for anyone to answer. The people who are in the North really don't care as they will soon be gone. — It is the native people

themselves who will have to demand a stake in the future. If not for themselves then for their children.

C.O.P.E. has tried hard to make it known to the government which is suppose to represent us that the needs of the native people must come first. We have worked long hours dealing with many complaints that come to us daily.

Because that pressure was put on the government - The government has said that native people must be given jobs first and that every effort must be made in encouraging natve people to take part in job opportunities- This was good for a while now we see and hear statements like 'Native people are unrealiable' ofcourse we have our lazy people but we cannot say that for max/ all the people. Many times workers with experience in heavy duty equipment, steamers, other trades are only hired as labourers.

Even though we feel we have made some progress - this situation will get worse as things go faster and faster. The only way we can help resolve these problems is to work together for native people.

It is \$4\$\$7\$\$\$\$/ easy for government bodies and developers to talk on wy they know what is best for the native people. In southern Canada, after a hundred years of help, the Indian people are having a hard time

- (3) The Head Office of the Society shall be located in Inuvik, Northwest Territories, Canada.

While the founding members of COPE in 1970 were representatives from the Western Arctic Gwich'in and Inuvialuit people, by 1972 the COPE leadership had expressed the desire that the COPE organization be the primary voice for only Inuvialuit people. That action did not eliminate non-Inuvialuit from continuing with their participation and so Agnes Semmler, of Gwich'in ancestry, continued on for many years in an active leadership role.

At the Federation of Natives North of Sixty meeting, Inuvik, November 1972, a resolution was passed unanimously accepting the new COPE organization as the representative of the Western Arctic Inuit – the Inuvialuit.
